GUIDELINES FOR EXTENDED ABSTRACTS

The 2nd International Research Symposium on Management 2023 (IRSM 2023) invites submissions of extended abstracts based on original research. The deadline for submission is **July 15th**, **2023**. The abstracts must be prepared and formatted according to the guidelines given below.

1. General Instructions

- The extended abstracts should be written in English and free from grammatical and typographical errors. The author/s should proofread the manuscript carefully before the submission.
- The extended abstract content must be organized under the major headings Introduction, Methodology, Results and Discussion, Conclusions and Implications, and References. Sub-headings under the above major headings are not allowed.
- The extended abstract length should be between 1000-1500 words, including the list of references.
- The author must ensure that the extended abstract is saved as a Microsoft Word (doc/docx.) file.
- Authors' name/s, including names of all co-authors and their affiliations, should appear on a separate title page.
- The author should ensure that the extended abstracts submitted to the IRSM 2023 have not been published previously or are not under consideration for publication by any other journals or conferences. Accordingly, the author must submit the "Author Declaration Form" when the camera-ready copy is submitted.
- At the initial stage, the author/s can decide whether to join IRSM 2023 for oral or poster presentations.
- The final decision to accept or reject the extended abstracts will be under the editorial board's authority with the reviewers' recommendations.
- IRSM 2023 collaborates with several local peer-reviewed journals to identify and publish high-quality research papers submitted to IRSM 2023. However, the editorial board will decide the suitability of the extended abstracts for journal publications. The editorial board of the following collaborated journals reserves the right to determine the suitability of the manuscripts for publication, followed by a full paper reviewing process:

2. Template and Content of Extended Abstract

INTRODUCTION

This section shall detail about background information relating to the study. The author/s may also mention significance and contribution of the study, while specifying how it relates or differs from those of previous studies. The scope and limitations of the study may also be included in this section.

Specific issues, contradictions, or gaps in knowledge that the study addresses shall also be discussed in this section while citing relevant sources of literature as evidence for or justification of the research problem. Then, a clear statement/s of objective/s need to be provided for addressing the research problem/s.

METHODOLOGY

The methodology shall be clearly stated and described in sufficient detail with sufficient citations. It shall describe, if any, the research framework and related hypotheses, and the methods applied for data collection and analysis in detail. It should be further highlighted why the chosen method(s) are suited for the research problem.

RESULTS AND DISCUSSION

This section shall summarize and briefly discuss the main findings of the research, using data, figures, tables, etc. The findings shall also be compared to other studies or generally accepted knowledge in the field.

CONCLUSIONS AND IMPLICATIONS

This section shall include the principles and generalizations inferred from the results, any problems or limitations of the work, and theoretical and/or practical implications of the study. All the conclusions should be supported by the information provided in the results and discussion section.

Keywords: A maximum of five keywords can be included. The keywords should be placed in alphabetical order.

Funding/Acknowledgement: The author(s) shall declare all sources of funding/ acknowledge any individual or organization directly contributed to the study.

REFERENCES

References shall be listed in alphabetical order and presented according to the APA style - 7th edition (for more information http://www.apastyle.org/).


